IV. Discussion Items

a. School Strategic Plan

- i. Strategic Plan and Priorities Review: Strategic plan, currently with 11 priorities, set to expire in 2026. As the year continues, will work on new goals and action steps. CIP connected to Strategic Plan Priorities, with key indicators such as reading on grade level/showing growth in ELA, building systems and support to enhance IB/PYP/DLI/Gifted collaboration, and ensuring subgroups are making academic progress across all subject areas.
- ii. **SMART Goals:** Goals include increasing overall ELA proficiency from 75% to 80%, increasing overall Math proficiency from 74.6% to 80%, and reduction of 2% in behavior referrals

b. Data Discussion

- i. MAP Results:
 - Overall 80th percentile for achievement and 79th percentile for growth Fall 2024 to Fall 2025
 - 2. Reading 65th and Math 68th percentiles for growth

ii. 2025 GA Milestones Results:

- 1. 74% proficiency in ELA, 71% proficiency in Math and 62% proficiency in Science for 3rd through 5th grades
- 2. Year over year reduction in ELA and Math proficiency for Hispanic subgroup, however, SGP growth is high
- 3. CCRPI target preview overall meeting ELA and Math targets with flags overall for Science, Black subgroup for ELA and Math, Hispanic subgroup for ELA, and ED subgroup for ELA and Math

V. Information Items

- a. **Principal's Report**
 - i. **Enrollment and Leveling Updates:** Projected 888 students and enrolled 894 students, thus a \$35,772 upward budget adjustment. Currently enrollment is 903 students, however, post 15-day count, and therefore no additional budget adjustments. Reserve budget of \$192,171 released.
 - ii. Staffing Update: Reserve budget will be used primarily for two additional intervention teachers, full-time non-instructional para and stipends/supplies/etc. to support professional learning opportunities and strategic plan goals. Three Special Education teachers funded by the District due to leveling.
- b. APS Forward 2040 Comprehensive Long-Range Facilities Plan Update Refined version of facilities scenarios to be released early next week per APS communication sent out today. Engagement opportunities next week on
