IV. Discussion Items

- a. **2025 2030 Strategic Plan Development:** Aligned to Board and District goals; getting back to basics.
 - i. Key Performance Indicators: Reviewed three goals for APS. As it relates to Morris Brandon, one APS goal is to increase the percentage of 3rd grade students scoring proficient or above in ELA by 20 percentage points by 2030. For 3rd Grade ELA, Morris Brandon came above the school average at 76.5% proficient and above. Reviewed KPI goals for APS to align and inform Morris Brandon's goals as well as utilize for the strategic plan goals.
 - ii. CCRPI: School rating is from last year's data; very strong and holding to prior data at 5% growth in reading and math. CCRPI score will be released mid-November and will have discussions at that point.
 - iii. Purpose of school's strategic planning is to create alignment across the district, reduce confusion and simply efforts. Need to vote and have 2030 strategic goals and objectives completed by January 2026, before the budget process starts.
 - iv. Divided into 5 groups and discussed the following strategic focus areas (refer to the recording link for complete discussion):
 - 1. Strengthening instructional core,
 - 2. Caring for every child,
 - 3. Our strength is our team,
 - 4. Our responsibility is shared, and
 - 5. Our system is efficient and effective.
 - v. Reviewed and confirmed alignment on the mission, vision and purpose. Teachers refined in prior years and no updates were deemed necessary at this time.
 - vi. Reviewed and confirmed alignment between school's three Continuous Improvement Plan (CIP) goals and four 2030 strategic plan goals.
