#### IV. Discussion Items

### a. 2025 – 2030 Strategic Plan Development

- i. Confirmed mission/vision and goals from prior meeting. Aligned that no change was needed to the mission and vision. Reviewed District's Strategic Plan, which includes six focus areas 1) our strength is our team, 2) our responsibility is shared, 3) our system is efficient and effective, 4) we are strengthening our instructional core, 5) we are caring for every child, and 6) we are sparking student curiosity. Discussed alignment of the school's goals with the District's focus areas and identifying strategic objectives under four key performance indicators (KPIs) that were identified for the school in prior meeting. The KPIs take into consideration the school's internal Continuous Improvement Goals. The four KPIs for 2030 are 1) increasing third-grade ELA proficiency, 2) improving growth percentiles for African American students, 3) increasing student comfort in seeking help from adults, and 4) boosting staff engagement.
- ii. Developed 2025-2030 strategic plan objectives. Compared and aligned current strategic plan objectives to school's KPIs and District's Strategic Plan focus areas where applicable. Discussed identifying and adding new strategic plan objectives to fill gaps in KPIs and focus areas. New objectives included 1) create opportunities for all families to increase engagement, 2) ensure exceptional education students are making yearly gains in literacy rates and state targets for ELA and math, and 3) build systems and resources to support the Enhanced IB PYP, DLI and gifted collaboration. Discussed several ideas for additional new objectives; will review in next meeting.
