a. Principal's Report

- i. Leveling update/ Current Enrollment: projected 844 with current at 871 including 16 students in Autism Program. Extra funds used to support intervention teacher (side note avg teacher provided by APS salary up \$17K so this could be potentially budget issue for next school year) and remainder for materials/supplies. Also able to fully fund substitute teaching line item for full year
- ii. Strategic Plan: refer to MB website for reference.
- iii. CIP Goals
 - 1. Continued growth in literacy (+4%)
 - 2. Focus on support, implementation, and monitoring of new math standards (-3%)
 - 3. Support extremely elevated / elevated BASC3 students

iv. SMART Goals

- 1. Literacy at 71%, move up +5%
- 2. Numeracy at 69%, move up +5%
- 3. BASC3 results to continue to improve

v. MAP data

- 1. Brandon continues to outpace district with proficient and above
- 2. Subgroup data available in deck
- 3. But noticed the drop in number of 4th and 5th grade students year over year discussion for later but how do we encourage more families to stay through fifth grade?
